**VACANCY NOTIFICATION**

The Andaman and Nicobar Administration has decided to start the first ever Law College for the benefit of the islanders at Port Blair. Accordingly, the administration has set up a Society called "Andaman and Nicobar Islands Legal Education Society" (ANILES), with Hon'ble Lt. Governor as the President of the Society. The Society is fully funded by the Administration.

**Essential qualification & experience for Principal :**

(A)

- i. An eminent scholar with Ph.D qualification(s) in the concerned/ allied / relevant discipline and published work of high quality, actively engaged in research with evidence of published work with a minimum of 10 publications as books and /or research/policy papers.
- ii. A minimum of ten years of teaching experience in University / College, and /or experience in research at the University/ National level institutions/ industries, including experience of guiding candidates for research at doctoral level;
- iii. Contribution to educational innovation, design of new curricular and courses , and technology- mediated teaching learning process;
- iv. Adequate administrative experience.

(B) An outstanding professional, with established reputation in the relevant field, who has made significant contributions to the knowledge in the concerned/ allied/ relevant discipline, to be substantiated by credentials.

**Essential qualification & experience for Assistant Professor :**

- (i) Good academic record as defined by the Pondicherry University with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in the relevant subject from an Indian University, or an equivalent degree from an accredited foreign university;
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/ SET;
- (iii) Notwithstanding anything contained in sub-clauses (i) and (ii) above, candidates, who are or have been awarded a Ph.D. degree in accordance with the University Grants Commission (minimum Standards and Procedure for Award of Ph.D. degree) Regulations, 2009/ other exemptions by UGC shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/ Colleges/ Institution;
- (iv) NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted.



**College Director of Physical Education and Sports:**


- (i) A Master's Degree in Physical Education or Master's Degree in Sports Science with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) with a consistently good academic record.
- (ii) Record of having represented the University/ College at the inter-University /inter-collegiate completions or the State and /or National championships.
- (iii) Qualifying in the National Level test conducted for the purpose by the UGC or any other agency approved by the UGC.
- (iv) Passed the Physical fitness test conducted in accordance with these Regulations.
- (v) However, candidates, who are, or have been awarded Ph.D degree in accordance with the "University Grants Commission(Minimum Standards and Procedure for award of Ph.D Degree), Regulations 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of University Assistant Director of Physical Education/ College Director of Physical Education & Sports.

**College Librarian :**

- (i) A Master's Degree in Library Science/ Information Science/ Documentation Science or an equivalent professional degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed ) and a consistently good academic record with knowledge of computerization of library.
- (ii) Qualifying in the national level test conducted for the purpose by the UGC or any other agency approved by the UGC.
- (iii) However, candidates, who are, or have been awarded Ph.D degree in accordance with the "University Grants Commission(Minimum Standards and Procedure for award of Ph.D Degree), Regulations 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of University Assistant Director of Physical Education/ College Director of Physical Education & Sports.

- (i) Candidates are requested to submit their complete curriculum vitae to Secretary (Law), Andaman & Nicobar Administration, Port Blair – 744 101 within 30 days from the date of notification of vacancy.
- (ii) The short listed candidates will be called for interview before the Selection Committee constituted by ANILES. The interview may be held either directly or by video conferencing.
- (iii) The decision of the Executive Council of ANILES chaired by Chief Secretary to Andaman & Nicobar Administration on the selection of the candidates for various faculty position will be final.
