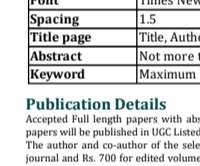

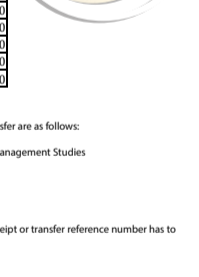

ONLY original research contributions will be entertained after carrying out plagiarism check through TURNITIN®.
