Terms and Conditions:

- 1. All the interested firms / companies may submit the EoI along with non-refundable fee of amount Rs.10,000/- in the form of DD in favour of The Finance Officer, Pondicherry University, payable at Puducherry in a sealed cover marked "Expression of Interest Response e-Learning Solution".
- 2. Firms / Companies should submit their EoI which includes the following:
 - a. Eol in the format given
 - b. Non-Refundable Fee, as given above
 - c. Documentary proof to prove the qualification and capability of the firm/company as required.
 - d. Commitment to implement the required e-Learning for the subjects of 4 year Engineering Courses of Mechanical, Electrical, Electronics, Civil, Computer Science and Information Technology and other Allied branches of study, within the time frame specified by the University
 - e. Acceptance to give Technical Presentation on invitation
 - f. No Costing / Pricing is required at this stage
- 3. The EoI can be submitted by a consortium consisting of maximum two Technical Companies registered in India operating in Education sector. A legally binding consortium agreement duly notarized shall be submitted in support of this, where in the roles and responsibilities of each consortium partners shall be clearly specified and all the consortium partners shall be jointly and severally held responsible for the implementation of the project till the validity of the contract. One of the consortium partners should be the original developer of e-learning solution.
- 4. The University will scrutinize the EoI responses received and announce the short listed firms / companies.
- 5. The qualified firms / companies will be invited for a Technical Presentation and Discussion with the University Technical Committee. Date, Time and Venue for the technical presentation will be informed in the invitation.
- 6. The short listed firms / companies from the Technical Presentation will be Invited to participate in the Bid and the bid documents will be supplied to them.
- 7. The bids received will be subject to technical evaluation by the University and the commercial bids of those bidders who qualify in the technical evaluation will only be opened.

- 8. The firms must be willing to develop e-learning material as per the curricular and requirement of the Pondicherry University.
- 9. Primary contact number, fax number, email-id and name / designation of the contract person are to be submitted along-with the EoI.
- 10. Participation by qualified and short listed firms / companies throughout the bidding process is compulsory and lack of interest or non-participation in any event would be a sufficient reason to disqualify the firm / company / consortium at any stage.
- 11. No further correspondence would be made by University with disqualified firms / Companies. Any claim by the disqualified firms / companies citing reasons for non-participation on any grounds would not be entertained.

Mandatory Qualifications

The interested firm / company / consortium shall fulfill all of the following pre-qualification

- 1. The firm / company / consortium must be a National Lever It Organization / Content Developer with experience in the field of application software conceptualization, design, and development including content for Engineering Education, Development, Content Customization and maintenance for at least 4 years.
- 2. The Firm / company or its Consortium Partner should have the annual turnover minimum of Rs.8 crore in the last financial year.
- 3. The Firm / company / consortium and its Consortium Partner must be a Registered Company in India with valid VAT / LST / CST, Service Tax Registration and PAN number allotted by the respective authorities.
- 4. The Firm / company or its Consortium Partner should have appropriate ISO Certification or CMM certification level.
- 5. The Firm / Company or its Consortium Partner should have completed / launched Engineering content as required in this EoI, in the last 4 Financial years to:
 - i. A minimum of one Technical Board/University constituents/affiliated Engineering Institutes.
 - ii. A minimum of 50 Engineering Colleges / Institutes across various Universities in different parts of India.

- 6. The Firm / company or its Consortium Partner shall have ready availability of minimum of 100 Subjects relevant to Graduate Engineering Education of any University / Institute of repute.
- 7. Supply to any Central Institute like IIT / NIT will be an added advantage.

Short listed of firms/companies/consortiums:

- 1. All the firms/companies/consortia who have submitted their EoIs will be scrutinized by the University Technical Committee.
- 2. The qualified firms/companies/consortia shall make a presentation for assessment and short listing of firms/companies/consortia to submit their proposals for final selections.
