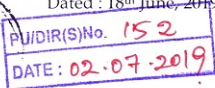

The National Human Rights Commission (NHRC) has an important mandate to promote the human rights literacy and awareness among various sections of the society as per Section 12 (h) of the Protection of Human Rights Act, 1993. Accordingly, NHRC has been supporting training programmes to be organized by institutions such as yours, for sensitization of Government Officials / Field Functionaries on human rights.

2. We provide financial assistance to institutions for Basic Training Programme on Human Rights for a duration of one day for 100 students with financial assistance of Rs.75,000/-. We would also provide a resource person for a session to give the NHRC perspectives on human rights.

Further, it is also intimated that NHRC also welcomes the *students* to visit the Commission to learn and familiarize with the day-to-day functioning and working of the organisation in protection and promotion of human rights of the citizens. You may send them for gaining a rich experience for half or full day attachment at your own expenses.
4. We would appreciate, if a detailed proposal from your Institution for holding programmes on human rights in your institution in the prescribed proforma (copy enclosed) and dates of visit to the NHRC during 2019-2020 are sent to us at the earliest.
