Pondicherry, officially known as Puducherry, is one of the Union Territories of India. This former French colony is a perfect amalgamation of the traditional Indian sensibilities and French architecture. The coastal city is dotted with beaches, beautiful promenades and watching the sun rise over the deep blue expanse of the Bay of Bengal is an experience. Conceived as the 'Universal Town', Auroville is an experimental township where people from across the world of all cultures and traditions come and live together in peace.
