 - d) OBC certificate with Non- Creamy Layer certificate recently issued (i.e. issued after April 2017) by competent authority, in case of OBC candidates.
 - e) Recent SC/ST/PH/Pondicherry Residence certificate/Karaikal Residence Certificate from competent authority as applicable
 - f) Migration/Transfer certificate and Conduct certificate from the institution last studied
 - g) Recently taken two stamp size color photographs (For Group Medical Insurance Policy)
 - h) Soft copy of color passport size photograph in a CD (for Library and ID card)
 - i) One set of Xerox copies of all certificates as stated above should be submitted.
 - j) If admission is given, the candidate should be in position to pay the Admission fees (Approx Rs.40,000/-) immediately either though online / Indian Bank Chalan.
 - k) If the candidate fails to fulfill any of the above criteria, the seat will be allotted to the next candidate. No time will be granted for payment of fees and submission of certificates.
 - 1) Seats will be allotted on the basis of rank order only
 - m) Only Rank from 1 to 600 is invited for 1st round counselling. Final Admission would be based on availability of seats.
 - n) If Admission is given for one MBA, Candidate is not permitted to shift from one MBA program to another MBA program even if vacancies arise on later date.
