## NABARD Student Internship Scheme-2020-21

We are pleased to inform that National Bank for Agriculture and Rural Development (NABARD) propose to implement the Student Internship Scheme from 01 April 2020.

The features of the scheme are given below:

- Students with good academic background, who have completed first year of Post Graduation, pursuing courses in Agriculture, Agri-Business Economics, Social Studies and Management, will be considered.
- A maximum of 05 applications will be entertained from any institution / university. Curriculum Vitae of the students recommended may be forwarded in the enclosed format (Annexure I).
- Based on the academic qualifications, the eligible students would be shortlisted for interview.
- The selected students will be assigned short term tasks/projects/ studies, useful and relevant to NABARD and they will have to submit a study report on the theme assigned to them. For example, they will be asked to conduct a study on one of the themes indicated in Annexure II or they may be given some other theme as may be decided by the NABARD, Tamil Nadu Regional Office.
- The students appearing for the interview may also bring a synoptic note (research proposal) on any one topics of the Scheme which will help the interview committee to judge their aptitude towards research in a better way. In case of exceptional proposal, the student may continue with his / her chosen topic.
- . The time frame for completion of the assignment is minimum 8 weeks to maximum of 03 months
- The selected candidates will undergo a one week orientation programme in our Regional Office and they should commence the study as early as possible.  The selected candidates will be paid a consolidated stipend of Rs. 14,000/- p.m for the duration of the entire period of the assignment i.e., 8-12 weeks

(maximum of 3 months).

Selected students shall also be paid field visit allowance of Rs.1000/- per day, inclusive of all expenses towards lodging, boarding, etc. (during the actual period of field visit subject to a maximum of 30 days) and local conveyance of Rs.300/- per day (maximum 15 days) for visit to Govt. offices/Banks/agencies for collection of data/information within Head Quarters.

The selected students have to give an undertaking to NABARD to the effect that he/she will have no right/ claim on report submitted to the Bank, after completion of the assignment, except submission to his/her university/ Institute and NABARD shall be free to use the same in the manner considered appropriate by it.

- The selected students should also give a declaration that he/she will maintain complete secrecy and shall not use for any other purpose any information of confidential nature that might come to his/her knowledge during the period of assignment under the scheme.
- The decision of NABARD with regard to selection of candidates will be final.

We request you to please announce the scheme to the eligible students of your University/Institution and forward the names of a maximum of 5 students for our consideration on or before 10 March 2020.
