Registrar (Purchase & Stores), Pondicherry University, Puducherry – 605 014 are invited on or before 3.00 p.m. on 20/02/2013, to make a rate contract for purchase of **LCD Multimedia Projector with Ceiling Mount Kit** as per the detailed specification given below: -

Terms and Conditions

- 1) The price quoted by the bidder is inclusive of delivery and installation (including testing, connecting with other peripherals, commissioning and make functional) of the equipments.
- 2) **Duty Exemption:** The University has been granted the benefit of exemption from payment of the Central Excise Duty and Customs duty by the Department of Scientific and Industrial Research (DSIR), India, vide their Notification No. 10/97 dt. 01/03/1997 and 23/07/96 respectively.
- 3) The rate selected by the Purchase Committee under this tender, may prevail as Rate Contract for the next one year and supply order can be issued on repeat order basis.

- 4) The Projector should be covered under **3 years warranty**. If any item covered under warranty fails, the same shall be replaced free of cost including all the applicable charges including transporting cost (both ways).
- 5) The Tender must be accompanied by **EMD amount of Rs.5,000/- & Tender Document Fee for Rs. 100/-** by means of Demand Draft, drawn in favour of **the Finance Officer, Pondicherry University, payable at Puducherry** separately. *The EMD amount is refundable. The Small Scale units are exempted from payment of EMD provided they enclose proof of their valid exemption Certificate issued by the competent authority.*
- 6) **The quotations should reach the Asst. Registrar (Purchase & Stores), Pondicherry University on or before 3.00 P.M. on 20/02/2013 and the same will be opened on the same day at 3.30 P.M. in the presence of bidders.** The offers will not be considered if received after the bid closing date and time.
- 7) The EMD & TDF should be submitted along with quotation in a sealed cover, super-scribing thereon bidder's name and name of the Item. Any tender, submitted without EMD/TDF, will not be accepted.
- 8) The validity of the each quotation should be at least 180 days from closing date of the bid.
- 9) The offers received through telex / tele-fax / e-mail will not be accepted by the University under any circumstances.
- 10) The University shall not be responsible for any delay / loss or non-receipt of tenders by post / courier service.
- 11) No unsolicited correspondence shall be entertained after the submission of the offer.
- 12) Tender is not transferable.
- 13) All equipment must operate at 230V/50 Hz single phase and / or equivalent three phase electrical power.
- 14) **The firm must have the requisite domain expertise with regard to supply, installation and post-sale service of the items they are quoting.**
- 15) Please give the recent customers list with contact details including email address.
- 16) If you have an authorized representative / dealer, you are requested to furnish technical ability to take care of the problems in the system, if developed later within the warranty and outside the warranty period.
- 17) Pondicherry University reserves the right to accept / reject any offer in full or in part or accept any offer other than the lowest offer without assigning any reason thereof. Any offer containing incorrect and incomplete information shall be liable for rejection.

- 18) Out of total contract/ purchase price, 90% of the amount will be paid on satisfactory installations. Balance of 10% of the amount shall be retained as Security Deposit, towards satisfactory performance of the equipment, and which may be released on submission of a **performance bond supported by a Bank guarantee (obtained from Nationalized Bank of India) for the 10% of the total contract/ purchase value, for the duration of the Warranty period.**
- 19) In case of any dispute in respect of the tender, all legal matters shall be instituted within the jurisdiction of the place where the item is installed.
- 20) Timely supply of the ordered items, installation, commissioning (wherever applicable) and training etc., is the essence of the contract. In case of failure to supply within the time specified in the Purchase order, a penalty/LD of 0.5% of the total value per week or a part thereof shall be levied subject to a maximum of 7.5% in respect of items which are not supplied. The decision of Pondicherry University shall be final in this regard.
- 21) The Successful bidders should supply the items, etc, **within a week** after receipt of the firm supply orders.
- 22) Complete technical specifications including process flow, to be included with the quotation. Manufacturers of various major parts/equipment must be mentioned explicitly, Literature, user manual if any are to be attached with the quotation.
- 23) Additional terms and conditions will be incorporated in the purchase order, if needed, to safe guard the interests of the University.
- 24) **Quoting merely the lowest price does not confer any right to any bidder for award of supply order. The University's Purchase Committee, reserves the right to select any bid under the grounds of proven performance track record, brand reputation, service backup support, additional warranty, offer of additional / special features, compatibility, etc.**
- 25) The University reserves the right to reject the any bids with unbranded / sub-standard brand / un-certified brands of products even if they found to be lowest.
