Sealed quotations under two bid systems are invited for "Supply, Delivery, Installation and Commissioning of Complete Analytical Cum Semi Preparative High Performance Liquid Chromatography System with Accessories" under DST-SERB project "Microbial metabolites as antiquorum sensing agent for the development of novel anti-infectives". The quotations duly signed and sealed should be sent by Post (Normal / Speed / Registered / Courier) to Dr. Busi Siddhardha, Assistant Professor and Project Investigator, Department of Microbiology, Pondicherry University, Puducherry-605 014. The price quoted should include all the costs such as delivery, installation, testing etc., and also inclusive of all taxes. Warranty terms should be explicitly specified in your quotation.

The technical specifications are given below.

The HPLC system shall include the following individual stackable self-contained modules.

The HPLC system must be controllable, monitored, capable of performing system maintenance using Microsoft Internet Explorer web browser.

Modules must be connected via fibre optic noise resistant high-speed transmission technology to enhance the reliability and sensitivity of the HPLC.

- 1. Solvent Delivery System for Micro, Semi-Micro, Analytical, Semi-Prep flow rates
  - Pump 2 No's (For high Pressure gradient Application)
  - It must be a high speed double micro-plunger in-parallel pump with automatic pulsation correction mechanism achieving pulse-free solvent delivery.
  - Each pump flow rate should be settable between 0.001 to 10 ml/min from micro to semi-preparative flow rates without any hardware changes

- Flow rate accuracy should be  $\pm 1\%$  or  $\pm 0.5 \mu$ l/min of set value whichever is larger
- Flow rate precision must be less than ±0.06% RSD
- Pressure setting range should be 1-40 MPa
- Pressure pulsation must not exceed 0.3 bar (0.03MPa)
- Should be up gradable as quaternary HPLC system at a later stage.
- The precision of composition must be less than 0.1% RSD.

- The wavelength range should be 190 nm 800 nm
- The photo-diode array detector should have 512 elements and an element resolution of 1.2nm/element must be available.
- The detector must have 2 modes of operation using a variable slit: High Resolution mode at a slit width of 1.2nm and a High Sensitivity mode at a slit width of 8nm
- The flow cells must be temperature controlled from ambient  $\pm 5^{\circ}$ C to  $50^{\circ}$ C
- Wavelength accuracy should be  $\pm 1 \text{ nm}$
- A deuterium lamp [D2] and a Tungsten lamp [W] should be available as Light Source for UV and visible wavelengths respectively.
- The selection of light source must be flexible to select D2, W or both [D2 +W] the lamps for analysis (3 modes)
- The Drift must be smaller than 0.5x10-3 AU/Hour
- The Noise Level must be smaller than 0.6x10-5 AU
- Linearity should be equal or more than 2.0AU (ASTM method)
- It should have automatic wavelength accuracy check at 4 wavelengths (UV & Vis) & wavelength correction
- It must have data buffering function to collect up to 20 min of data for all wavelength regions in case of PC malfunctions

- It should cover full one-point digital instrument control, qualitative and quantitative processing, report creation and self-diagnosis
- Sample schedule wizard function should be standard

- The data can be converted to other formats. Spread Sheet software and wordprocessing software can be readily employed to provide data in tables or graphs through industry standard protocols
- The software should allow automatic execution of system checks, auto-purge and baseline checks

I. General Information:

- b) Quotation / Tender processing fee: Rs. 1050/-
- c) EMD rates: Rs.50,000/-

d) Two bid system has to be strictly followed. One for Technical bid and another for commercial bid and each bid should be submitted in separate sealed covers superscribing name of the tender and bid (Technical/Commercial).

e) However, the tender processing fee and EMD as specified above should be remitted by each firm / bidder, collectively for all their bids advertised under this tender in the technical bid.

**f**) Quoting merely the lowest price does not confer any right to any bidder for award of supply order. The University's Purchase Committee, reserves the right to select the equipment any bid under the grounds of specification compliance, technologically advanced quality, proven performance track record, brand reputation, service backup support & training, offer of additional / special features, compatibility with the existing System, etc.

**g**) The Quotation / Tender processing Fee and EMD should be submitted along with your quotations.

h) The quotation must be submitted along with the stipulated quotation document fee and EMD in the sealed cover, super-scribing "<u>Supply, Delivery, Installation and</u> <u>Commissioning of Complete Analytical Cum Semi Preparative High Performance</u> <u>Liquid Chromatography System with Accessories</u>". The name and address of the bidder should also be mentioned at the from address space.

#### **II.** Common Conditions (Import or Indigenous)

#### 1. Purchase of Quotation Document:

The Quotation / Tender document fee should be in favour of **The Finance Officer**, **Pondicherry University**, **payable at Puducherry**. The tender documents should be accompanied with the tender processing fee, in the form of a Demand Draft.

#### 2. Price Schedule

The rates should be quoted for a single unit and also for the total quantity required by the University. The price should include the delivery, installation, training charges, etc. at the respective Department, Pondicherry University. The prices quoted shall remain firm until the equipment is supplied to the respective Department, Pondicherry University.

#### 3. Quoting the Core price & Tax, Duties, Discount etc.

The taxes / duties / discounts, if applicable, are to be explicitly and separately shown in the bid.

#### 4. Eligibility:

The firm must have the requisite domain expertise with regard to supply, installation and post-sale service of the items they are quoting. The firm should have been in existence for at least six years as on the date of this quotation and must have executed at least three orders for this kind of equipment during the last three years.

#### 5. Duty Exemption

The University has been granted the benefit of exemption from the payment of the Central Excise Duty and Customs Duty by the Department of Scientific and Industrial Research (DSIR), India, vide their Notification No.10/97 dt. 01-03-1997 and 51/96 dated 23.07.96 respectively, in respect of

a) Scientific and technical instruments, apparatus, equipment, Software including computers.

b) Accessories and spare parts of goods specified in (a) above and consumables.

c) Computer software, compact disks, CD ROM, Recording magnetic tapes, microfilms, microchips etc.

d) Prototypes.

Customs duties at Indian port, if any, will be to the account of the University.

#### 6. Technical Specifications

i. **WARRANTY:** The equipment covered under the purchase order, when installed, shall be warranted for the quality, workmanship, trouble free operation and performance for a period

of at least 36 months from the date of putting the system into operation at the Department of Microbiology, Pondicherry University.

ii. If any item covered under warranty fails, the same shall be replaced free of cost including all the applicable charges including shipping cost both ways.

iii. Complete technical specifications to be included in the Technical bid.

iv. The necessary service support should be provided by Bidder during the agreement period.

v. The training should be provided by the supplying companies for a minimum period of two days from the date of installation with an expert team.

vi. Technical post sale support by email and telephone will be provided during the period.

vii. Operating Manual should be provided in English.

viii. A clear statement regarding availability of after-sales service and availability of spareparts for next 3 to 6 years should be included.

ix. A recent customer list (within last five years) with contact details including email ad-dress is to be submitted with technical bids / bids as the case may be.

x. If the equipment is proprietary product, a proprietary product certificate should be enclosed.

xi. The information pertaining to infrastructural, power and any other requirement for satisfactory installation and commissioning of the whole system must be provided by the bidder, in one quote itself.

xii. The equipment must operate at 230V / 50 Hz single phase and / or equivalent three phase electrical power.

xiii. If the bidder is an authorized representative in India, they are requested to inform their technical ability to take care of the problems in the system, if developed later within the warranty and outside the warranty period. The responsibility of the Indian agent must be clearly specified.

xiv. The bidder from abroad shall obtain, if required, export permission from the appropriate authorities in his country or the country of origin for items to be shipped to India in case of items to be imported. The University shall provide necessary information if required for this purpose.

# xv. The validity of the each quotation should be at least for THREE MONTHS from closing date.

xvi. The offers will not be considered if received after the bid closing date and time.

xvii. The offers received through telex / telefax / e-mail will not be accepted by the University under any circumstances.

xviii. The University shall not be responsible for any delay / loss or non-receipt of quotations by post / courier service.

xix. No unsolicited correspondence shall be entertained after the submission of the offer.

xx. If an order is placed with the firm, the purchase shall be governed by an agreement as per the University rules in force at the time.

xxi. Additional terms and conditions will be incorporated in the purchase order, if needed, to safe guard the interests of the University.

xxii. Quotation is not transferable.

xxiii. In case of any dispute in respect of the quotation, all legal matters shall be instituted within the jurisdiction of the place where the purchaser ordinarily resides.

## 7. Power to reject the offer:

i. Pondicherry University reserves the right to accept / reject any offer in full or in part or accept any offer other than the lowest offer without assigning any reason thereof. Any offer containing incorrect and incomplete information shall be liable for rejection.

ii. No Agency commission will be paid to any authorized agent in India.

iii. Liquidated damages: Timely supply of the ordered items, installation, commissioning (wherever is applicable) and training etc. is the essence of the contract. In case of failure to supply within the time specified in the Purchase order, a penalty / LD of 0.5% of the total value per week or a part thereof shall be levied subject to a maximum of 7.5% in respect of items which are not supplied. The decision of Pondicherry University shall be final in this regard.

iv. Bidder(s) must be authorized business partners of Global / National service providers of the respective equipment.

v. The Bidders must enclose authorization letter from the respective global / national service providers of the above equipment particularly mentioning an undertaking that in case of default by the Bidder, they (Global Service Provider) shall take over all the responsibilities of the Bidder.

vi. The Bidder should not be involved in any Bankruptcy filing for protection from it.

## **III. Specific Conditions for Imported Equipment**

## 1. Payment of EMD:

The Quotation must be accompanied by EMD as stated above, by means of a Demand Draft, drawn in favour of *The Finance Officer, Pondicherry University, payable at Puducherry. The Small Scale units are exempted from payment of EMD provided they enclose the proof of their exemption Certificate issued by the competent authority.* 

#### 2. Payments terms:

Normally a payment 90% will be released after the installation & training. However, 100% payment will be released **if the supplier provides Bank Guarantee** towards performance Security for the 10 % of the total cost of the equipment to cover the warranty period. Bank charges in India shall be borne by the purchaser and outside India shall be borne by the contractor / supplier. The offer must be in English. The rates should be indicated both in figures and words against item specified in the given table.
