The University of Kashmir is an autonomous state University that was founded in the year 1948 and it has been re-accredited as Grade-A University by the National Assessment & Accreditation Council (NAAC) of India. The campus of the University is around 10 Kms away from the main city Centre, Lal Chowk, which is hub of all the commercial activities. The University Campus is flanked by the world famous Dal Lake at Hazratbal on its eastern side and Nigeen Lake on the western side. It has 14 faculties, 02 constituent colleges and more than 125 affiliated colleges. The University besides having a sprawling Main Campus at Srinagar has established Satellite Campuses at Anantnag (South Campus), Baramulla (North Campus), Kupwara, Kargil and Leh. Nearly 15000 students are enrolled in around 39 PG Programmes offered by the University both through formal and non-formal mode.
