Sir,

The University Grants Commission intends to implement certain items of Cultural Exchange Programmes/ Educational Exchange Programme (EEP) entered into by the Government of India with foreign countries. These interalia provide for visits of Indian teachers to these countries for a study - com lectures, exchange of information; establishing contacts and participation in conference, seminar symposia. The teachers nominated under this programme would be provided to and fro travel by the University Grants Commission and the maintenance in the foreign country would be provided by the host Govt. as per the provisions of the Cultural Exchange Programme. The nominated teacher would be required to be paid full salary and allowances for the duration of his/her visit abroad and may be treated as on duty as per University rules.

12.	The parties shall exchange history and geography information that can be included in text books in the other country.
