In continuation of the Circular 4th cited and as per instructions contained in letter 5th, 6th and 7th cited, it is submitted that the Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training, Government of India has extended the time limit for filing of revised returns by all the Central Government employees from 30th April, 2015 to 15th October, 2015. Thus, the last date for filing revised property returns by those who have filed returns under the existing rules, stands extended upto 15th October, 2015. Also, the Ministry has given clarification to all Ministries/Departments that every public servant [all Officers/employees under Groups A, B & C] has been advised of the following:

- The annual Immovable Property Return (IPR), as on 31.12.2014, under the existing CCS (Conduct) Rules, 1964 is required to be filed on or before 31.01.2015;
- The first return under the Lokpal and Lokayuktas Act, 2013 (as on 01.08.2014) should be filed on or before 30.04.2015 (now extended upto <u>15th October 2015</u>);
- iii) The next annual return under the Lokpal and Lokayuktas Act, 2013, for the year ending 31.03.2015, should be filed on or before 31.07.2015; and
- iv) The annual return for subsequent years as on 31st March every year should be filed on or before 31st July of that year.

Also the Ministry has given clarification, regarding formats to be used for filling Assets & Liabilities returns under the section 44 of the Lokpal and Lokayuktas Act, 2013, as follows:

A. Declaration to be filed with Return of Assets and Liabilities on First Appointment or as on the 31st March, 20....... (Under Sec 44 of the Lokpal and Lokayuktas Act, 2013)

- (a) FORM No. I Details of Public Servant, his/her spouse and dependent children.
- (b) Modified FORM No. II Statement of movable property on first appointment or as on the 31st March, 20......
- (c) FORM No. III Statement of immovable property on first appointment or as on the 31st March, 20...... (e.g. Lands, House, Shops, Other Buildings, etc.) [Held by Public Servant, his/her spouse and dependent children]
- (d) Modified FORM No. IV Statement of Depts and other Liabilities on first appointment or as on 31st March, 20......

In view of above, all the employees of this University, both Teaching and Non-Teaching are requested to file the IPRs under the CCS (Conduct) Rules, 1964 and the return under the Section 44 of the Lokpal and Lokayuktas Act, 2013 within the revised time-limit i.e. on or before <u>15th October 2015</u>, in the afore-mentioned forms A and B (a,b, c & d) which are also enclosed for kind reference.
