PUDUCHERRY STATE POST-MATRIC SCHOLARSHIP SCHEME

60 No. of awards are proposed to be awarded to the meritorious students whose parental annual income does not exceed Rs.25,000/- for U.G. Level. There is no income ceiling for P.G. students.

The awards under the above scheme will be made on the basis of the results of the following examinations in the year 2011-2012.

- i) H.Sc. examination or other equivalent Examination (U.G. Level)
- Degree examination viz., B.A./B.Sc./B.Com. or other equivalent examinations (P.G. Level)

FINANCIAL ASSISTANCE TO POST GRADUATE STUDENTS.

About 66 Nos. of scholarships are proposed to be awarded to the meritorious students whose parental income does not exceed 25,000/- per annum for pursuing their higher studies in Arts, Science, Professional courses, etc. in the recognized Colleges/Institutions of this Union Territory of Puducherry/Other states as per the conditions stated in Clause II "General conditions of Eligibility". The awards under this scheme will be made on the merit basis of the results of the following examination of 2008-09.

First degree examination viz. B.A/B.Sc./B.Com or other equivalent diploma/degree in Technical and professional courses.

AMOUNT OF SCHOLARSHIP

For Puducherry State Post Matric Scholarship Scheme

- a) A sum of Rs.60/- per month for day scholars and Rs.100/- per month for hostellers will be paid for Higher Secondary/first year of 3 years B.A./B.Sc./B.Com. etc. courses.
- b) A sum of Rs.90/- per month for day scholars and Rs.140/- per month for hostellers will be paid for the II and III year B.A/B.Sc./B.Com. etc.
- c) A sum of Rs.120/- per month day scholars and Rs.300/- per month for hostellers will be paid for the M.A./M.Sc./M.Com. and Engineering/Medical/Professional Courses.

For Financial Assistance to Post Graduate Students

A sum of Rs.120/- per month for Day Scholars and Rs.300/- per month for hosteller will be paid to Engineering and all other Higher Courses of study.

GENERAL CONDITIONS OF ELIGIBILITY

- a) The Candidates must be citizens of India and belong to the Union Territory of Puducherry either by birth or by domicile.
- b) The candidates who have passed the qualifying examination in their first attempt only will be eligible for consideration.
- c) The candidates who have appeared as well as passed the qualifying examination in a year prior to 2012 will not be eligible for consideration.
- d) The candidates who have passed the qualifying examination in first class or secured not less than 60 % of mark in aggregate in the qualifying examinations in the academic year 2011-2012 are eligible for consideration.
- e) Income of the parents/guardians should not exceed Rs.25,000/- per annum for Puducherry State Post Matric Scholarship Scheme (U.G. Level) There is no income ceiling to the students who are studying Post-graduate course.
- f) Income affidavit should be furnished obtained from the Deputy Tahsildar, O/o the Taluk, Govt. of Puducherry.
- g) In case of pensioner, a copy of the Pension Payment Order should be enclosed.
- h) It may be ensured that the students once selected and recommended for this scholarship are not recommended again for any other scholarship.

MODE OF APPLYING

The candidates pursuing higher education and who wish to apply for fresh scholarships for the year 2012-2013 under any of the above Scholarship Schemes may visit the website www.dhte.puducherry.gov.in. and can download the application forms.

The students should submit their applications to the Directorate of Higher and Technical Education, Puducherry, through the Head of their Institution on or before 20.02.2013. The Head of Institutions should furnish the details of the applicants in the prescribed proforma (I), in the descending order of the marks obtained in the qualifying examination.

Applications received after 20.02.2013 will not be considered on any account. Incomplete applications will be rejected without any consideration. Students should take utmost care in filling up the forms to avoid rejections and they should see that their applications are received by their Head of Institution/Directorate of Higher and Technical Education within the scheduled time.

RENEWAL OF SCHOLARSHIPS

The students who have received scholarship from this administration during 2011-2012 and in the preceding year are eligible for renewal of scholarships subject to fulfillment of the conditions laid down in the Scholarship Schemes. The last date of submission of renewal proposal by the Heads of Institutions is fixed as 20.02.2013 and the details of applicants may be furnished in the proforma (II) as given below alongwith a copy of the sanction/G.O vide which the applicants were awarded scholarship during the previous years.
