As you are aware, India is a party to the 'Convention on Biological Diversity (CBD)' which recognizes the sovereign rights of each country to use its own biological resources. In order to realize the objectives of this international convention, India has enacted an umbrella legislation called the 'Biological Diversity Act, 2002', which enshrined conservation of biological resources, modalities for accessing these resources and equitable sharing of benefits accruing out of their commercial use, among different stakeholders.
