Respected Sir,

As you may be aware, the scheme of updation of the National Register of Citizens (NRC) 1951 in Assam is being updated under the provisions of Citizenship Act, 1955 and Citizenship Rules, 2003, as amended from time to time under the aegis of this office.

2. As per these statutes, the NRC would contain names of those persons (or their descendants) who appear in NRC 1951, or in any of the Electoral Rolls upto the midnight of 24<sup>th</sup> March, 1971 or in any other admissible documents issued upto the cut-off date, which would prove their presence in Assam or any part of the country on or before the said date. Under the process, Application Forms (family-wise) were invited from all households with supporting documents. The particulars furnished by the citizens in their Applications are to be verified and based on the results of verification, the NRC would be updated and a draft NRC published.

3. In this connection, Hon'ble Supreme Court, which is regularly monitoring the progress of the NRC updation work, has issued directions for extending help to the State Coordinator, NRC, Assam for validation of documents related to different Universities in the country from official records. The State Coordinator, NRC, Assam has sent the first batch of documents to the Registrars of different Universities in the country, with a request to get the authenticity of the documents verified and provide the results of verification within 20 days of receipt of the request. The State Coordinator would be sending some more lots of documents to the various Registrars of Universities.

4. Currently, the NRC updation work is in its peak and it is imperative that the verification process is completed at the earliest so that the draft and final NRC could be published in time.

5. In view of the above, I request you to issue necessary directions to the various Universities across the various States/UTs in the country to extend their cooperation and assistance in the verification of the documents and provide the results thereof to the State Coordinator, NRC, Assam preferably within 20 days from the date of receipt of the request.


