Kindly send the duly completed nominations for an individual or institution that merit any of the above awards at an early date to avoid rush of nominations towards the last date prescribed.

- 4. Please avoid expensive enclosures. Only one Xerox copy of the enclosures need be sent. "Originals should not be sent". Please note that it will not be possible for us to return the material sent to us in support of the nomination.
- 5. Please specify the sphere of activity for which the nominee is sponsored.
- Please affix a copy of the recent passport size photograph of the nominee in the space provided for, in the nomination form.
- In case of institutions, specify whether it is a registered society or trust.
- Please indicate the broad sources of finance supporting the activities of the nominee (e.g. grants from Government, donations from Indian / Foreign sources).
