6. Lodging for Escorts/Team Manager

Only one person accompanying the participating team in debates both in Hindi and English will be provided boarding/lodging facility.

7. Location of the Venue

**NICM, Chennai is located at 2377-A, 12<sup>th</sup> Main Road, Shanti Colony, West Annanagar, Chennai.** It is 16 kms. from Chennai Central Railway Station and 12 Km. from Egmore Rly. Station, Chennai. The distance from Chennai Bus Terminal, Chennai is 2.05 Kms.

8. Weather at Chennai

Chennai is situated in the Southern region of the Country and experiences pleasant weather during the winter session. The participants are advised to bring warm clothes to avoid cold during their journey period.

9. Traveling Expenses

The Council will reimburse the traveling cost of participants(2<sup>nd</sup> Class rail fare) as per rules of the NCCT which includes Daily Allowance for the total period of 4 days including to and fro journey period @ Rs. 100/- per day and Rs.200/- maximum as conveyance charge for above journeys. They are expected to travel on students concessional tickets as far as possible. If it is not feasible due
