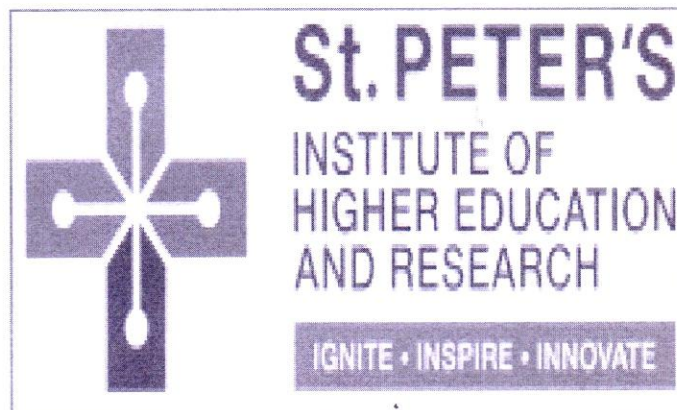

February 28th is celebrated as National Science Day in commemoration of the invention made by Sir C.V. Raman, Raman Effect. It was on 28th February 1928 C.V.R. announced the Raman Effect at the Indian Institute of Science in Bangalore and was awarded the Nobel Prize in Physics in 1930. St. Peter's Institute of Higher Education and Research takes great pride in constituting Sir C.V.Raman Scientist Award to be given every year from 2014 onwards. The award aims to promote innovative scientific research in reputed academic institutions/Universities/Research institutions within India by encouraging and rewarding innovations which have positive impact on our Society. St. Peter's Institute of Higher Education and Research proposes to award scientists/academicians for their excellence in original innovative work in Science and Technology. The award carries a cash prize and a citation.

Selection Procedure

The awards will be given annually as per the recommendations of the Award Committee comprising of eminent scientists, technologists and specialists in diverse areas of Science and Technology.

Eligibility Criteria

- The innovation should either be a new product, process or an improvement thereof so as to increase its utility by enhancing advantages and improvement in performance for benefit of the society.
- Publications in reputed Journals and Patents.
- Mere theoretical hypothesis, concepts still in an idea stage and perceptions like that of perpetual motion machines are not eligible for consideration.
- Age limit: below 45 years.

Who can apply?

- ❖ The award will be given only to the individual who has contributed to the innovation.
- ❖ Teachers working in the recognized academic Institutions/Universities in India.
- ❖ Scientists working in recognized R&D establishments in Government/Private Sector in India.

Completed application (4 bound copies) in sealed cover (both hard and soft copies) should reach **The Dean (R&D), St.Peter's Institute of Higher Education and Research, Avadi, Chennai-600 054, Tamil Nadu,** on or before **08.02.2019**.

General Conditions

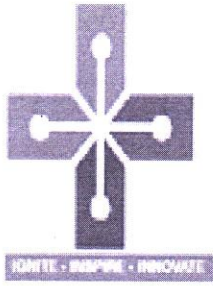
- ❖ The applicant employed in any organization should forward his/her application through the **Head of the Organization**.
