CIRCULAR

Sub: Filing of Income Tax calculation Statement for the year 2014-2015 by the Faculty members, Officers, and Staff of this University-Reg.

The Income Tax calculation statement is to be submitted by all the staff members of the University whose annual gross total income is expected to cross Rs.2,50,000/- in the case of all the members during the financial year 2014-15 and Rs.3,00,000/- in the case of Senior Citizen with 60 years and above. The Income Tax calculation statement proforma along with instructions for filling up the statement can be down loaded from the University website. The PAN number along with Xerox copy of the PAN Card should necessarily be furnished along with Income Tax statement form as per our format. IT calculation statement will not be accepted in case the PAN Number is not mentioned in the statement.

For availing the various deductions under Income Tax Act the relevant instructions and the time schedule attached herewith is to be strictly adhered to by all the assesses. In order to allow deduction towards rent paid as per serial no: 2 (i) of the profoma, the officials concerned should produce the rent receipt (format enclosed). Deduction will not be considered if rent receipt in original is not produced. Exemption for HRA includes Basic + Grade Pay & DA. While furnishing the Income Tax calculation statement relevant proof for Savings/Investments made to be attached. Any incomplete statement without relevant proof as per the instructions for claiming the deductions will not be considered. Also in case of failure to comply with the time schedule given in the instructions for filling the Income Tax statement, the Finance and Accounts section will be compelled to calculate and deduct Income Tax for those assesses on the basis of the information available in the University. Income Tax as per the University's calculation will be recovered from such assesses from salary payable during October 2014 to February 2015. To avoid problems in finalizing the Income Tax, we strictly impose deadline to submit the IT calculation statement by 10th October 2014 failing which the salary for the month of October 2014 will be withheld without any further communication. The statements received without proof will be returned immediately or the amount will not be considered for Tax deduction.

The Statement along with the relevant proof may be submitted to the Undersigned on or before 10th October 2014.

To avoid any complication in this regard all the assesses are hereby requested to cooperate with the Finance and Accounts section strictly by adhering to the instructions and by keeping up the time schedule which would facilitate them to discharge this important statutory obligation of Income Tax remittance smoothly.

Form 16 once issued will not be revised no duplicate issued. Employees are requested to keep sufficient no. of copies of Form 16 before submission to Income Tax Dept.

The return of income is a legal document. It must, therefore, be filed in and signed in ink. An unsigned return will be treated as invalid.

Note 1	The PAN number should be necessarily filled at the Part-A of the Income Tax Statement Form. Any form submitted without copy of PAN number will not be accepted and it will be returned to the individuals immediately. Non submission of PAN will attract deduction of TDS @ 20%					
Note 2	The pay arrears/D.A. arrears received during the financial year should be included under Sl.No.1 (I)					
Note 3	All the additional income received by way of honorarium, remuneration from Pondicherry University and other institutions are to be included under Sl.No.1 (II)
