

Sir,

In a partial modification of the existing norms of the Junior Research Fellowships, the Upgradation of Fellowship may be done after the completion of the first two years of JRF at University/Institution/College level constituting a Three Member Committee in which one Outside subject Expert is mandatory. A nominee may be constituted at the level of University/Institution/Colleges for evaluation of progress of work of JRF. The recommendation of the Committee in the prescribed proforma is enclosed herewith may be submitted to this office for our record. The approval from UGC for upgradation is not mandatory henceforth, but the record of number of scholars upgraded may be furnished by University/Institution/College in order to release SRF instalment.
