In spite of several reminders and circulars issued to the NPS Subscribers cited in the Annexure have not submitted their filled in application (Form S-1) to the undersigned towards registering them in the NSDL, Mumbai for the allotment of PRAN ID under New Pension Scheme.

In the absence of PRAN ID the University could not transfer their NPS accumulation to the NSDL Mumbai. In this case the provision of annual interest may not be applicable.

As per the PFDRA norms, the employee cannot be considered under NPS category without PRAN ID. They will be depraved of all the benefits under NPS.

PRAN ID is a statutory obligation on the part of the employee of the University who are under the NPS.

Therefore, the NPS subscribers cited in the Annexure are hereby directed to submit their PRAN Application (Form S-1) along with the cancelled cheque leaf on or before 27/11/2013 to the undersigned without fail.

If the applications are not received on or before 27/11/2013 their salary may have to withheld till the completion of the NPS Registration procedures with the NSDL, Mumbai and PFDRA, New Delhi.
