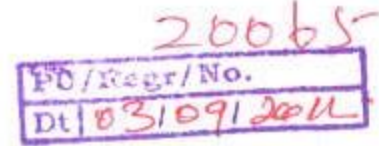

<b>Experience</b>	At least 15 years of experience in post carrying Grade Pay / Academic Grade Pay of Rs. 7,000/- and above along with experience in educational administration <b>OR</b> Comparable experience of equivalent grades in research establishment and/or other institutions of higher education <b>OR</b> 15 years of administrative experience in a University / R & D Institution / Government Organization / Autonomous Body under the administrative control of Government of India of which at least 8 years as the Deputy Registrar or an equivalent post in the PB-3 in Grade Pay of Rs. 7600/- and above.
<b>Desirable</b>	Degree in Law / Management. Proven experience in Human Relations Management, Personnel Management preferably in large Educational or Research Institute and experience in all aspects of academic administration.
<b>Job Description</b>	Incumbent is expected to participate in decision making process at the conceptual level. The incumbent will be over-all in-charge of Administration, Finance & Accounts, Stores and Purchase, Contract Services, Estate etc. and is also expected to provide administrative support to the Director. - 1) The above post is as per the Central Government pay scales and carry allowances like Dearness, House Rent and Transport as per Govt. of India rules.
- 2) Preference may be given to those applicants who are willing to join on deputation terms.
- 3) The qualification prescribed should have been obtained from recognized Universities/ Institutions. Relaxation in educational qualification and / or experience will be considered in case of exceptionally meritorious applicants with prior approval of the Competent Authority.
- 4) Age relaxation will be considered in case of SC/ST/OBC/Physical handicapped and Ex-servicemen applicants as applicable but in any case age shall not be more than 55 years as on closing date of the advertisement.
