## About the Conference

The premier duty of a democratic government like ours' is to provide peace, prosperity and justice to the people. This duty of the Government can be achieved by following the principles of Rule of Law. In democracy, people of India are the supreme. To give emphasis to this, the Supreme Court of India in *Rangnath Mishra vs. Union of India* (fundamental duties case) said that, "the highest office in our democracy is the office of citizens; this is not platitude, it must translate into reality". Thus, it becomes highly indispensable to protect and preserve the rights of the citizens despite all distracting obligations and uphold their Justice. This is when the law enforcement agencies steps in through their expertise activities. Implementing law and maintaining order are the prime responsibilities of the enforcement agencies. In the present day, the role of these law enforcement agencies has become very sensitive and crucial. All the organs of the law enforcement agencies play different role in different phases. Thus, whatever be the situation these agencies should work towards the administration of justice and strike a balance between the rights of the citizens and justice.
