Sub: End Semester Examination under CBCS regulations, November 2016 – Payment of Exam fees & submission of filled-in exam applications - Reg.

The P.G. Semester Examinations for November-2016 session is scheduled to be held from 21.11.2016. The details of payment of fees & last date for submission of filled-in examination applications are given below:-

a.	Examination fees per credit	: Rs. 16/-
b.	Last date for payment of exam. fees a) without fine b) with fine @ Rs. 50/-	: 14.11.2016 : 15.11.2016
c.	Last date for submission of filled-in exam applications to the Academic Section	: 16.11.2016
d.	Commencement of Examinations	: 21.11.2016
e.	Completion of Examinations	: 02.12.2016
f.	Declaration of provisional results	: 05.12.2016
g.	Submission of results to the Academic Section	: 10.12.2016

No student shall be permitted to appear for the end semester examinations *without Hall Ticket and without the required attendance of 70%* in each course (as per CBCS regulations). Students with less than 70% of attendance should not be allowed to write semester examination of the subject(s) concerned. The subject concerned may be rounded or cancelled in the application/Hall ticket itself.

It is requested that the results of the semester examinations may be sent along with a soft copy in the following Excel(.xls) format.

Note : A separate excel sheet (including all the subjects) may be used for each batch of students.

The end semester results may be prepared and sent to the Academic Section as noted below:

1. The original Minutes of the Programme Committee Meeting duly signed by all the members of the Committee.

- 2. The register numbers in each Softcore/Hardcore results should be arranged in the ascending order (Department wise) with the signature of all concerned (Vice
- 3. The format which is enclosed mentioning the criteria for converting the marks to grade should be enclosed with the signature of all concerned as prescribed in the format.
- 4. As per CBCS regulations, a student can drop the course before the end of 3<sup>rd</sup> week of the semester. Hence request for dropping of course will not be entertained beyond the 3<sup>rd</sup> week of semester.
- 5. The complete end semester result for the Department should be spiral bound and sent to the Academic Section. The result should not be sent in bits & pieces.
- 6. The student can appear for end semester examination only for the papers registered by him and results for all the papers registered by him should be furnished.
