I – Sealed Quotations are invited for the purchase of 50nos of Teak Wood Electronic Table required for establishment of new lab **under two bid system** as per the details given below:-

Teak Wood Electronic Table	Teak wood Electronic Table with provision for keeping the Computer Regent Rack & Switch Boxes – Table : Size:135 x 90 x 75cms. Cupboard with shelf and locking arrangements. Right side one key board and cupboard with sliding door. Leg Size: 6 x 6cms. Top side and back cross reaper size: 9 x 3cms. Bottom cross reaper 4.5 x 3cms and other reapers 7 x 3cms. Table bottom planks 2cms thick 5 joints and 6 planks all side planks 1cm thick. Table top 18mm water proof plywood with 1mm thick mica finish. Teak wood Regent Rack size:105x 40x60cms with 18mm thick plank with one joint. Two switch boxes each of size:40 x 15 x 5cms. Bottom 6mm plywood , top 3mm Formica with 15 Amps & 5 Amps switch and socket each 2 nos in a box.	

II – (i) The prospective bidders are required to submit Technical and Financial Bid in separate sealed covers duly superscribed. The documentary proof along with photograph (if any) to be submitted to establish that they are fulfilling the below mentioned eight eligibility criteria, along with the Technical Bid.

- (a) Quality Certification
- (b) Experience in the field - The firm should have been in **existence for at least last five years** (proof to be attached)
- (c) Proof of annual turnover during last three years should be submitted
- (d) Earlier should have supplied similar items to the Academic Institutions / Laboratories / Libraries etc., - Customer List.
- (e) Sample quality and workmanship.
- (f) The proof of following documents should be enclosed.
 - i. Copy of Registration Certificate
 - ii. Copy of PGST/CST registration
 - iii. PAN allotted by Income Tax Department
- (g) Only manufacturers or exclusive authorized dealers/resellers of such products are permitted to quote against the requirements.

- (h) The firm should have executed orders in the last financial year for Government / Public Sector organizations / Large private organization of repute (proof to be attached).

III) The price bids should be submitted in a separate sealed envelope Superscripting “Commercial Bid”. On the basis of the Technical / Eligibility Bid, submitted by the bidders pre-qualification will be made in the light of the eligibility criteria set by the University. The price bids of only such pre-qualified bidder alone will be opened, duly informed of.

IV) The original manufacturer of the modular furniture who had already supplied similar kinds of furniture for the Institutes of Higher Education are also free to quote with any other model of their own product with similar specification or considered to be parallel or better models and products of the notified items under this tender

V) - Terms and Conditions:-

- 1) The quotations should be sealed and superscripted as “Quotation invited for supply and installation of Electronic Teak Wood Table.
- 2) The quotations should reach the above said address on or before 3.00 P.M. on 25.05.2012 and it will opened on the same day by 3.30 P.M.
- 3) Quotation must be valid for one year from the date of opening.
- 4) The rates should be inclusive of all taxes, octroi, Insurance, Packing , forwarding, transit etc,
- 5) The University has the right to select or reject any quotation partly or fully without assigning any reason thereof.. The rate quoted shall be “FOR destination” basis at our premises.
- 6) Payment will be made only after satisfactory supply and after getting a Certification of Quality of the entire consignment by the Quality Inspection Committee.
- 7) An amount of Rs.15,000/- should be remitted as EMD in the form of a Demand Draft from any one of the nationalized banks, drawn in favour of The Finance Officer, Pondicherry University, payable at Pondicherry.
- 8) The bids without the E.M.D. will be summarily rejected.
- 9) **The best sample of the firms has to be submitted along with quotation. The bids without sample may not be considered**
- 10) The final selection will be made based on the acceptance of the sample/model approved by the University and not on the basis of L-1 rates only.
