- Age relaxation and reservation for SC/ST/OBC/PWD etc. will be as per Government of India rules. The correct date for determining the age limit shall be the closing date for receipt of applications.
- 4. The posts of Assistant and Accountant are identified for persons with disabilities (BL, OA, OL, HH) and DEO is identified for OL, BL, LV, HH. One vacancy in the post of Assistant/Accountant will be reserved if the post is filled up on direct recruitment basis. If reserved, the vacancy will be open to both the identified categories of disability, namely, Locomotor Disability or Cerebral Palsy and Hearing Impairment.
