It is proposed to fill up one (01) post of Superintending Epigraphist (Dravidian Inscription) Group 'A' Gazetted in level 11 of the pay matrix in the Archaeological Survey of India on Deputation (including short term contract) as per the eligibility criteria indicated below:

Deputation (including short term contract):

Officers under the Central Government, State Government Union Remiones, Public Sector Undertaking, Universities, Recognized Research Institutions, Semi-Government, Statutory or Autonomous organizations:

A. (1) holding analogous post on regular basis in the parent cadre, department; or

(II) with five years service in the grade rendered after appointment thereto on a regular basis in post in level 10 of the pay matrix or equivalent in the parent cadre, department; and

- B. Possessing the educational qualifications and experience prescribed for direct recruits under column 7 of the Recrutiement Rules of the post, viz;-
  - (I) Master Degree in Tamil or Telugu or Malayalam or Kannada with Ancient Indian History as a subject at Bachelor Degree level from a recognized University.

    Or

Master Degree in History with Ancient Indian History as a subject and Tamil or Telugu or Malayalam or Kannada as one of the subjects at Bachelor's Degree level from a recognized University.

- (II) Seven years experience in copying, deciphering and editing of inscriptions in the concerned discipline.
- (III) Doctorate Degree in any of the above subjects.

## Note 1:

Qualifications are relaxable at the discretion of the Union Public Service Commission, for reasons to be recorded in writing, in case of candidates otherwise well qualified.

### Note 2:

The qualification regarding experience is relaxable at the discretion of the Union Public Service Commission for reasons to be recorded in writing, in case of candidates belonging to the Scheduled Castes or the Scheduled Tribes, if at any stage of selection the Union Public Service Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the posts reserved for them.

# <u>Note 3:</u>

The Departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Period of deputation (including short term Contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation (including short term contract) shall not be exceeding fifty six (56) years as on the closing date of receipt of applications.

### Note 4:

(I) For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1-1-2006 or the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the pay commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.

(II)The officer selected will be on deputation for a period of three years and will be governed by terms of deputation laid down in DoPT O.M. No. 2/12/87-Estt. dated 2904.1988 as amended from time to time and pay will be regulated in accordance with the DoPT O.M. No. 1/99/91-Estt. (Pay-II) dated 5.1.1994 as amended from time to time.

(III)Application in duplicate in the proforma attached herewith (Annexure-A) along with the complete and up-to date ACRs/APARs of the Officers who can be spared in the event of his/her selection, may be sent to the undersigned through proper channel within 60 days from the date of publication of this advertisement in the Employment News. Application received after the last date or otherwise found incomplete will not be considered.

(IV) while forwarding the application, it may be verified and certified that the particulars furnished by the officers are correct and that no disciplinary action/court case is pending or contemplated against the officers and also no major/minor penalty has been imposed on the officers during the last ten years.

(V)The officers who apply for the post will not be allowed to withdraw their nomination subsequently.
