Sub: PU – Estt – Result Framework Document -Updation of web-sites of Central Universities -Reg.

Ref: Letter No. D.O.No.F.19-31/2014 Desk (U) dated 28.04.2014 of ShriPrمود Kumar Saha, Deputy Secretary to Government of India, Department of Higher Education, , Ministry of Human Resource Development, New Delhi.

The Ministry of Human Resource Development, Government of India, New Delhi in the letter cited has stated that operationalisation of portal for Central Universities as one of the items in Result Framework Document for the year 2014-2015 of Department of Higher Education, MHRD and this target should be achieved before 30.09.2014. In view of the above, the Ministry has proposed to develop a Web-based System to deal with issues pertaining to the Governance and information of the Central universities. In this connection the Ministry has set up the following key parameters where the information/data are required to be updated:-

No	Key parameter where the information/data has to be updated
a	Committees and Reports- Provision to upload Committees and Reports
b	Central Acts and Ordinance- Provision to upload all Acts and Ordinance.
c	Circulars/Orders/Notifications- Provision to upload Circulars/ Orders/Notifications for viewing single/all/multiple by Universities or by public
d	University Details- Provision to capture basic detail of the University like: i. Address ii. Website URL iii. Contact Details including Phone/Fax/e-mail address iv. Year of Establishment v. Logo.
e	Profile, tenure and contact details of Vice Chancellor/Pro-Vice-Chancellor/Registrar/Finance Officer/Controller of Examination.
F	Statutory Bodies- Details of all the Statutory bodies i.e., Academic Council, Executive Council, Court and Finance Committee. Members' details of each statutory body slot wise, with tenure, Social Category etc. Accordingly, monitoring reports on tenure expiry, slot wise vacancy position, Visitor Nominees, Members holding multiple positions within university or across the Universities etc.
g	Budget- Provision to enter the financial year wise budget sanction under various components and utilization details.

The Ministry has fixed 30.09.2014 as target date for this Result Framework Document item.

Therefore, as per the directions of the Ministry, the Systems Manager, Computer Centre of this university is requested to make suitable provisions & arrangement in our University's website to incorporate/update the required key parameters expected by the Ministry. Also all the Officers who are dealing with the above subjects are hereby requested to update the data/information relevant to their office and send the same to the Systems Manager, Computer Centre, ^{at the earliest} to enable him to update/incorporate the information/data in the University website well in advance to adhere to the target date fixed by the MHRD.
