The scheme envisages to provide ten thousand (10,000) fresh scholarships every year beginning from the academic year 2014-15. The scholarship will be given to students with domicile of NER who have passed Class XII or equivalent exam from a school situated within NER through any recognized Board of Education within NER only, and have secured admission in general degree course, technical and professional courses including medical and para-medical courses (Integrated courses included) in Universities/Colleges/Institutions recognized by UGC under Section 2(f) of UGC Act, within and outside the States of NER. 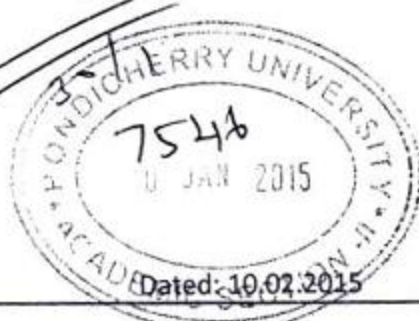

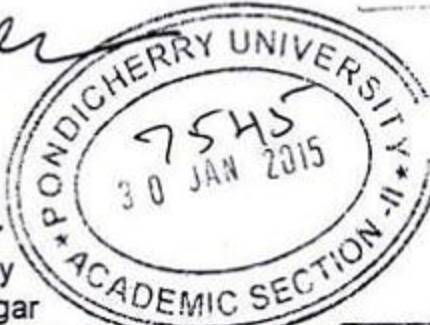
