Dear Colleagues,

Department of Social Justice and Empowerment is implementing several schemes for the welfare of the marginalised and poorest sections of the society. This includes the schemes for SCs, OBCs, Senior citizens, Drug dependent sections, Safai Karmacharis, Transgender, Beggars etc. The Department spends annually around Rs. 10,000 crore for implementation of these schemes.

2. With a view to ensure that these schemes are implemented in a diligent manner, to assess the functioning of various institutions funded for the above purpose by the Department and to evaluate the outcomes achieved, it is proposed to set up a **Project Monitoring Unit (PMU)** in the Department with dedicated, energetic and capable youth recruited from the top 75 institutions [ranked as per the National Institutional Ranking Framework (NIRF) 2019]. The students who are in the passing out batch of these institutions either degree/ post graduation below 25 years of age, or have passed out from these institutions in the last 2 years would be eligible for consideration. An online portal on socialjustice.nic.in would be for taking online applications from **4th February to 29th February, 2020** from eligible candidates. The job description, emoluments payable etc. is enclosed to this letter.

As Head of one of the top ranking institutions as per NIRF, I would request you to widely canvass this opportunity among your students with societal orientation (and passed students through Alumni Associations) so that we can have good response for the call before the deadline on **29th February, 2020**.
