- 1.The Tender should be sealed and superscripted as "Tender for supply & Installation of Steel Furniture items"
- The Tender should reach the Asst. Registrar, Purchase & Stores, Pondicherry University on or before 3.00 p.m. on 29.5:2019 and it will be opened on the same day by 3.30 p.m.
- 3The rates quoted in the tender should be valid for Six months from the date of approval.
- The rates should be inclusive of all taxes, octroi, installation, Insurance, packing forwarding, Transit charges etc. with warranty for 5 years.
- 5. Payment will be made after supply and installation

- 6.The EMD amount (2.5% of quoted price) should be remitted in the form of Demand draft from any one of the Nationalized Banks, drawn in favour of The Finance Officer, Pondicherry University, payable at Pondicherry.
- 7.Tender document fee, for an amount or Rs. 2,500/- in the form of Demand Draft from any one of the nationalized banks, drawn in favour of The Finance Officer, Pondicherry University, payable at Pondicherry should be submitted.
- 8. The Tender without the EMD, and Tender document Fee will be summarily rejected.
- Samples of items mentioned above should be provided for inspection. Tender submitted without sample will
 not be considered
- 10. The University has the right to select or reject any Tender partly or fully without assigning any reason.
- 11. The rate quoted shall be on FOR destination (Pondicherry University) basis at our premises.
- Manufactures/ authorized dealers registration Certificate under Companies Act, PAN, TIN No., GST Registration Certificate etc., should be provided.
- 13. Manufactures/ authorized dealers income Tax Returns for the last three years should be submitted and Proof of turnover of Rs.35 lakhs per year also to be enclosed.
- 14. Quoting merely the lowest price does not confer any right to any tender for the award of Supply Order. The University Purchase Committee reserves the right to select any tender under the grounds of specifications compliance, proven performance track record, service backup support etc.
- 15.A list of customers to whom major supply were made during last 3 years may be furnished along with their contact details, email address.
- 16.The tender is open to manufacturers and authorized distributors, who are having at least 3 years of experience in supplying of furniture items to the ministries / Government /Department/Public Sector
- 17.he tenderer should have an office in Puducherry/Chennai/ to render better and proper service after the purchase.
- 19.If Selected, the Tenderer have to supply the items mentioned in the Tender within 20 days from the date of Issue of supply order.
