- b) The quoted price should be inclusive of all taxes, packing, forwarding, transit, fixing, etc and supply shall be made at our premises.
- c) The University has the right to accept or reject any quotation partly or fully without assigning any reason thereof.
- d) Delivery is to be made within 15 days from the date of receipt of supply order.
- e) The finished goods should be strictly as per the specification. In case of any deviation, the University has the right to reject the goods.
- f) This tender is valid for 1 year from the date of confirmation of the rate.
- g) Only manufacturers or exclusive authorized dealers/resellers of such products are permitted to quote against the requirements. The firm should have been in existence for at least last one year (proof to be attached).
- h) The firm should have executed orders for substantial amount in the last financial year for Government / Public Sector organizations / R & D organizations / National laboratories (proof to be attached).
- i) An amount of Rs.10,000/- should be remitted as EMD in the form of Demand Draft from any one of the nationalized banks, drawn in favour of The Finance Officer, Pondicherry University, payable at Pondicherry.
- j) The best sample of the firms has to be submitted along with quotation. The final selection will be made based on the acceptance of the sample/model approved by the University and not on the basis of L-1 rates only
