NOTICE FOR HOSTEL MESS FEES

All the hostel inmates are requested to remit the **Mess Fees** for the even semester as follows:

- **P.G. Boys Students** -Rs.7,410/- (For the period from 18th January 2020 upto 10th May 2020) **(For 114 days @ Rs.65/- each)**
- **P.G. Girls Students** -Rs.7,410/- (For the period from 18th January 2020 upto 10th May 2020) **(For 114 days @ Rs.65/- each)**
- **Boys Research Scholars** -Rs.11,830/- (From 1st January 2020 to 30th June 2020. **(For 182 days @ Rs.65/- each)**
- **Girls Research Scholars** -Rs.11,830/- (From 1st January 2020 to 30th June 2020. **(For 182 days @ Rs.65/- each)**

The **Mess Bill** will be charged from the date of re-opening of the University departments i.e. 18th January 2020 unless the student has given prior intimation and applied for mess reduction. If mess reduction form is not given well in advance by the inmates, the mess bill will be charged from 18th January 2020 onwards.

The **Hostel Inmates** are requested to pay the **Mess Fees** on or before 18.01.2020.

Digital Payment Options:

As per the direction of MHRD/ UGC, Pondicherry University Hostel already implemented Digital Payment facilities to Hostel inmates for making hostel related payments. In this regard Pondicherry University Hostel have facilitated the following mode of payment to the Hostel inmates for collecting all hostel related fees similar to the previous semester.

1. Online Payment- through Net Banking.

Inmates are advised to pay the Hostel Fees through online payment using through Net-Banking. The details for adding Beneficiary are as follows:-

The inmates are asked to enter their Register No. available in the ID card in the remarks column.

After payments submit the receipt to the hostel office along with filled in remittance challan.

2. Handheld Device (Swiping Machine)

Handheld Device (Swiping Machine) are available in both Boys and Girls Hostel Office for the purpose of Hostel fees payment. The inmates are instructed to use the Debit or Credit Card along with the respective challans available in the Hostel Office and pay the hostel fees through the Handheld Device (Swiping Machine).

After payment submit the receipt to the hostel office along with filled in remittance challan.

3. Unified Payment Interface (UPI)

The Government of India has introduced a new app called Unified Payment Interface (UPI) for the purpose of payment fees. Indian Bank (Pondicherry University Branch) has also developed the UPI for the purpose of payment. Hence the inmates can utilize the above service and pay Hostel Fees.

QR Code may be used to pay the Hostel Fees through the following mode of payment.

- 1) Google Pay
- 2) Phone Pe
- 3) BHIM Pay
- 4) Pay TM
- 5) Other Unified Payment Interface (UPI) modes.

Quick Response Code (QR Code) is available for payment. The image of QR code is also pasted in C.V.Raman Hostel for the usage of Boys and Madame Curie Hostel for Girls. The inmates are requested to scan the QR Code and pay the Hostel Fees.

The inmates are asked to enter their Register No. available in the ID card in the remarks column.

After payments submit the receipt to the hostel office along with filled in remittance challan.

4. Normal Challan Mode

In addition to the above, normal challan mode payment is also accepted. Students may collect the challans available in the Office of the C.V.Raman Hostel and Madame Curie Hostel and remit the payment in the Indian Bank, Pondicherry University Branch.

All the inmates in the hostels are instructed to kindly cooperate with the system for payment in the interest of the university.
